- 1) In this simulation, all candidates not elected to the City Council are ineligible to receive ballots. Thus, in the 1st Round, the number of ballots received by each candidate is greater than the number received in the actual City Council election. Any ballot with a #1 vote for an excluded candidate is initially given to the first available choice among the 9 candidates eligible to receive.
- 2) In the 2nd Round, the candidate with the least votes (Reeves) is defeated and his votes are transferred to the next available choice (on each ballot) among the remaining 8 candidates. Note that in this simulation, this causes Simmons to vault from 6th place to 2nd place.
- 3) Votes tend to transfer, for the most part, within identifiable constituencies. Thus ballots initially cast for Reeves transfer primarily to another African-American candidate (Simmons). In the 3rd Round, when Toomey is defeated the votes transfer primarily to other "townies" like Michael Sullivan and Anthony Galluccio. In the 4th Round, when Murphy is defeated his votes transfer primarily to other "progressive" candidates (whatever that means).
- 4) After the 7th Round, the 3 remaining candidates (Sullivan, Davis, and Simmons) represent distinct, identifiable constituencies within the electorate. In the 8th Round, when Simmons is defeated, her votes transfer primarily to "progressive" candidate Davis rather than to "townie" candidate Galluccio and lift Davis past Galluccio by a 64 vote margin.
