


The ballot file contains 29 candidates and 16073 ballots. The names of the candidates on the ballots are Adkins, Lawrence J.; Cheung, Leland; Davis, Henrietta; Flanagan, Mark F.; Glick, Silvia P.; Kelley, Craig A.; Leavitt, Neal W.; Maher, David P.; Marquardt, Charles J.; Moree, Gregg J.; Podgers, Kathy; Reeves, Kenneth E.; Seidel, Sam; Simmons, E. Denise; Stohlman, Jr., Thomas J.; Sullivan, Edward J.; Toomey, Jr., Timothy J.; vanBeuzekom, Minka Y.; Ward, Larry W.; Williamson, James M.; Decker, Marjorie C.; Write-In 2; Write-In 3; Write-In 4; Write-In 5; Write-In 6; Write-In 7; Write-In 8; and Write-In 9.

The 29 candidates are competing for 9 seats, and the votes will be counted using Cambridge STV. The ballot file contains 15955 non-empty ballots. The winning threshold is set to 1596.


After 17 rounds of counting, the winners of the election are Kelley, Craig A.; Maher, David P.; Reeves, Kenneth E.; Seidel, Sam; Decker, Marjorie C.; Cheung, Leland; Davis, Henrietta; Simmons, E. Denise; and Toomey, Jr., Timothy J..




Count of first choices. Candidates Davis, Henrietta; Simmons, E. Denise; and Toomey, Jr., Timothy J. have reached the threshold and are elected. Candidates have surplus votes so surplus votes will be transferred for the next round.




Count after transferring surplus votes from Davis, Henrietta by using the Cincinnati method with a skip value of 7. Candidates have surplus votes so surplus votes will be transferred for the next round.




Count after transferring surplus votes from Simmons, E. Denise by using the Cincinnati method with a skip value of 9. Candidates have surplus votes so surplus votes will be transferred for the next round.




Count after transferring surplus votes from Toomey, Jr., Timothy J. by using the Cincinnati method with a skip value of 12. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Write-In 4, Write-In 5, Write-In 7, Write-In 8, Write-In 9, Write-In 6, Write-In 3, and Write-In 2 and transferring votes. Since this is the first elimination round, all candidates with fewer than 50 votes are eliminated. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Moree, Gregg J. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Williamson, James M. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Podgers, Kathy and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Adkins, Lawrence J. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Flanagan, Mark F. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Leavitt, Neal W. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.




Count after eliminating Glick, Silvia P. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.






Count after eliminating Marquardt, Charles J. and transferring votes. No candidates have surplus votes so candidates will be eliminated and their votes transferred for the next round.
